Mayor and Council did not convene into closed executive session. They discussed the item in the open meeting.

RECONVENE AND TAKE ACTION, IF ANY, ON ITEMS DISCUSSED IN III. **EXECUTIVE SESSION**

Mayor Essary asked Councilman Brown to summarize what had been done in looking for a search firm to find a new City Administrator. Councilman Brown said he and Ms. Sager, the City Administrator, sent out and received back four requests for proposals. He said all are very qualified. He said after some research he felt comfortable in recommending Strategic Government Resources (SGR) and McGrath Consulting. Councilman Brown reminded council that McGrath Consulting is who they used to hire the fire chief.

Council discussed Councilman Brown's recommendations. Both Councilman Brown and Councilman Smyre spoke highly of McGrath Consulting with their previous interactions during the hiring of the fire chief. Mayor Essary said one thing that McGrath Consulting has that the others probably do not is the head person is a psychologist. Consulting spends a lot of time trying to match the person with the entity they are trying to sell. The mayor said he saw them do that very well in matching up the new fire chief. Mayor Essary said the City of Piney Point Village used SGR and Mayor Butler was very pleased with them.

Motion was made by Councilman Brown and seconded by Councilwoman Schwartz to make an offer to McGrath Consulting and to come to the next council meeting to enter into a contract. Motion carried 4-0.

IV. DISCUSSION AND POSSIBLE ACTION REGARDING MEMORIAL VILLAGES POLICE DEPARTMENT REQUEST FOR INTERBUDGETARY TRANSFERS

- A. 2012 Budget Move \$20,000 from Health & Dental to the Legal & Professional Services line item
 - Chief Walpole said this is to cover the expenditures relating to the accounting firm hired due to the resignation of their financial person.
- B. 2011 Budget Move \$14,600 from Building to Automotive; \$4,900 from Office and Other Expenses to Automotive; \$1,200 from Insurance to Automotive; and \$2,253 from Personnel to Automotive

Chief Walpole said this is part of the audit clean up from the 2011 budget.

Motion was made by Councilman Smyre and seconded by Councilwoman Schwartz to authorize the interfund transfers. Motion carried 4-0
