## **DECLARATION OF DISASTER**

WHEREAS, on this 6th day of July, 2024, it has been determined that there is an imminent threat of damage, injury, and possible loss of life and/or property within the City of Bunker Hill Village, Texas, resulting from flooding and winds associated with Hurricane Beryl, and

WHEREAS, the Mayor of the City of Bunker Hill Village, Texas has determined that extraordinary measures must be taken to alleviate the suffering of people and to protect or rehabilitate property; now, therefore,

## BE IT ORDAINED BY THE MAYOR OF THE CITY OF BUNKER HILL VILLAGE, TEXAS

- **Section 1**. That a local state of disaster is hereby declared in the City of Bunker Hill Village, Texas pursuant to §418.108(a) of the Texas Government Code.
- **Section 2**. Pursuant to §418.108(b) of the Texas Government Code, this declaration of local disaster shall continue for a period of not more than seven (7) days from the date of this declaration, unless continued or renewed by the City Council of the Bunker Hill Village, Texas.
- **Section 3.** Pursuant to §418.108(c) of the Texas Government Code, this declaration of a local state of disaster shall be given prompt and general publicity and shall be filed promptly with the City Secretary.
- **Section 4.** Pursuant to §418.108(d) of the Texas Government Code, this declaration of a local disaster activates the City of Bunker Hill Village Emergency Management Plan.

**Section 5.** Pursuant to the State of Texas Declaration of Disaster issued July 5, 2024, by Lieutenant Governor Dan Patrick, certifying that Hurricane Beryl poses a threat of imminent disaster, including widespread and severe property damage, injury, and loss of life due to widespread flooding, life-threatening storm surge, damaging wind, and heavy rainfall.

**Section 6.** This proclamation shall take effect immediately from and after its issuance.

## **TEMPORARY CURFEW ORDER**

WHEREAS, on July 8, 2024, I, Robert P. Lord, the Mayor of the City of Bunker Hill Village, Harris County, Texas (the "City"), exercised my authority under Section 418.108 of the Texas Government Code to declare a local state of disaster for the City; and

WHEREAS, the imposition of a temporary curfew is necessary to protect public health and safety and to protect property from damage or destruction during this state of local disaster;

## FOR THE REASONS STATED I HEREBY ORDER AS FOLLOWS:

- **Section 1**. It shall be unlawful for any person to remain on, or travel upon, any public street, road, sidewalk or other public property in the City of Bunker Hill Village between the hours of 12:00 a.m. and 6:00 a.m. during the duration of this order.
- **Section 2.** The restrictions contained in section 1, above, shall not apply to police officers, fire fighters or any other persons authorized by local, state or federal governmental officials to assist in protecting public health and safety.
- **Section 3.** I hereby authorize the Memorial Village Police Department to enforce this order.
- **Section 4.** The regulations contained in this order shall remain in effect from July 8, 2024 until July 15, 2024 or until further action by me, whichever occurs first.
- **Section 5.** I hereby direct City staff to take steps to notify the public of this order and see that it is given prompt and general publicity and to see that the City Secretary promptly files the original of this Order in the City's official records.
