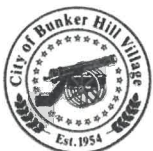
THIS BUDGET WILL RAISE MORE TOTAL PROPERTY TAXES THAN LAST YEAR'S BUDGET BY \$36,545 OR .60%, AND OF THAT AMOUNT, \$61,606 IS TAX REVENUE TO BE RAISED FROM NEW PROPERTY ADDED TO THE TAX ROLL THIS YEAR.

NOTICE OF 2018 TAX YEAR PROPOSED PROPERTY TAX RATE FOR CITY OF BUNKER HILL VILLAGE

A tax rate of \$0.277000 per \$100 valuation has been proposed for adoption by the governing body of City of Bunker Hill Village. This rate exceeds the lower of the effective or rollback tax rate, and state law requires that two public hearings be held by the governing body before adopting the proposed tax rate.

The governing body of City of Bunker Hill Village proposes to use revenue attributable to the tax rate increase for the purpose of funding public safety including Fire, EMS, Police and infrastructure which includes drainage, paving, water and wastewater utilities.

PROPOSED TAX RATE	\$0.277000 per \$100
PRECEDING YEAR'S TAX RATE	\$0.277000 per \$100
EFFECTIVE TAX RATE	\$0.278143 per \$100
ROLLBACK TAX RATE	\$0.267880 per \$100

The effective tax rate is the total tax rate needed to raise the same amount of property tax revenue for City of Bunker Hill Village from the same properties in both the 2017 tax year and the 2018 tax year.

The rollback tax rate is the highest tax rate that City of Bunker Hill Village may adopt before voters are entitled to petition for an election to limit the rate that may be approved to the rollback rate.

YOUR TAXES OWED UNDER ANY OF THE ABOVE RATES CAN BE CALCULATED AS
FOLLOWS:

$$\text{property tax amount} = (\text{rate}) \times (\text{taxable value of your property}) / 100$$
