

ORDINANCE NO. 18 - 501

AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY OF BUNKER HILL VILLAGE, TEXAS, BY DELETING SECTION 16-26, (1) - (4) OF ARTICLE II OF CHAPTER 16 THEREOF AND SUBSTITUTING THEREFORE A NEW SECTION 16-26, (1) - (4); ESTABLISHING RATES TO BE CHARGED BY THE CITY FOR WATER AND SANITARY SEWER SERVICES; REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES INCONSISTENT OR IN CONFLICT HEREWITH; AND PROVIDING FOR SEVERABILITY.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BUNKER HILL VILLAGE, TEXAS:

Section 1. The Code of Ordinances of the City of Bunker Hill Village, Texas, is hereby amended by striking from Article II of Chapter 16 thereof all of Section 16-26 and substituting therefore a new Section 16-26 to provide as follows:

Sec. 16-26. Bi-monthly charges.

From and after December 16, 2018 for water and sanitary sewer usage, the following bi-monthly (i.e. January-February, March-April, May-June, July-August, September-October, and November-December) rates shall be charged by the City of Bunker Hill Village for services of its waterworks system and its sanitary sewer system:

(1) Residential Water Charges:

- a. Minimum Charge, for water usage from
0 to 4,000 gallons.....\$89.25
- b. For each 1,000 gallons of water usage from
4,001 to 10,000 gallons..... \$2.55
- c. For each 1,000 gallons of water usage from
10,001 to 20,000 gallons..... \$2.80
- d. For each 1,000 gallons of water usage from
20,001 to 30,000 gallons..... \$4.80
- e. For each 1,000 gallons of water usage from
30,001 to 40,000 gallons..... \$5.45
- f. For each 1,000 gallons of water usage from
40,001 to 60,000 gallons..... \$6.40

- g. For each 1,000 gallons of water usage from
60,001 to 70,000 gallons..... \$7.85
- h. For each 1,000 gallons of water usage over 70,001 \$9.80

(2) Residential Sanitary Sewer Charges:

- a. Minimum charge including 0 to 1,000 gallons of water..... \$41.00
- b. for each additional 1,000 gallons of water usage:
 - 1. Single-family residential (1,001 to 40,000 gallons)..... \$1.60

(3) Non-Residential Water charges:

- a. Minimum Charge, for water usage from
0 to 4,000 gallons.....\$108.00
- b. For each 1,000 gallons of water usage from
4,001 to 10,000 gallons..... \$3.45
- c. For each 1,000 gallons of water usage from
10,001 to 20,000 gallons..... \$3.85
- d. For each 1,000 gallons of water usage from
20,001 to 30,000 gallons..... \$4.75
- e. For each 1,000 gallons of water usage from
30,001 to 40,000 gallons..... \$6.45
- f. For each 1,000 gallons of water usage from
40,001 to 60,000 gallons..... \$7.30
- g. For each 1,000 gallons of water usage from
60,001 to 70,000 gallons..... \$8.85
- h. For each 1,000 gallons of water usage over 70,001 \$10.25

(4) Non-Residential Sanitary Sewer Charges:

- a. Minimum charge including 0 to 1,000 gallons of water.....\$47.50
- b. for each additional 1,000 gallons of water usage: \$3.40

Section 2. All ordinances or parts of ordinances inconsistent or in conflict herewith are, to the extent of such inconsistency or conflict, hereby repealed.

Section 3. In the event any clause, phrase, provision, sentence, or part of this Ordinance or the application of the same to any person or circumstance shall for any reason be adjudged invalid or held unconstitutional by a court of competent jurisdiction, it shall not affect, impair, or invalidate this Ordinance as a whole or any part or provision hereof other than the part declared to be invalid or unconstitutional; and the City Council of the City of Bunker Hill Village, Texas, declares that it would have passed each and every part of the same notwithstanding the omission of any such part thus declared to be invalid or unconstitutional, whether there be one or more parts.
